ORDINANCE 2024-05

AN ORDINANCE BEING THE ANNUAL AMENDED APPROPRIATION BILL OF THE CITY OF WALLACE, COUNTY OF SHOSHONE, STATE OF IDAHO, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024, AND BY WHICH THE CORPORATE AUTHORITIES OF SAID CITY APPROPRIATE SUCH SUMS OF MONEY AS ARE DEEMED NECESSARY TO DEFRAY THE EXPENSES AND LIABILITIES OF SAID CITY, FOR THE SAID FISCAL YEAR, PURSUANT TO THE PROVISION OF SECTION 50-1003, IDAHO CODE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF WALLACE,
IDAHO:

SECTION 1. That Ordinance 2024-05, the appropriation ordinance for the City of Wallace, Idaho for the fiscal year beginning October 1, 2024 be and the same is hereby amended to reflect additional expense for the Street Fund. The following sums are hereby appropriated.
